




Who we are

Our utility business provides electric retail and wholesale power through five regulated utility operating companies – Entergy Arkansas, Entergy Louisiana, Entergy Mississippi, Entergy New Orleans and Entergy Texas.

We deliver natural gas service to customers in New Orleans and parts of Baton Rouge, Louisiana, through two regulated utility operating companies – Entergy New Orleans and Entergy Louisiana.
